5. That the school is not paying any charges towards using a name, motto, logo, or any other non-academic activities to any other institution, organization, or body.

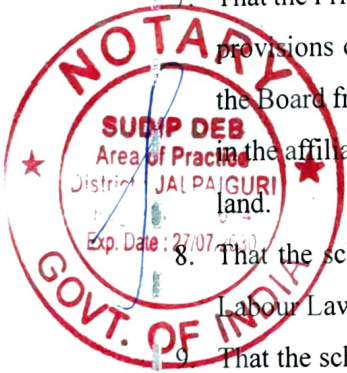

6. That the school will not open classes under CBSE pattern particularly (Class IX/X/XI/XII) and will not use the CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the school have gone through the various provisions contained in the affiliation & examination bylaws and the circulars issued by the Board from time to time and the school undertakes to abide by the provisions contained in the affiliation & examination bylaws, directions issued by the Board, and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI, and Labour Laws etc., with respect to the school and staff.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities.
10. That the school will ensure that all required infrastructure is available before starting classes.
11. That the school will ensure that a sufficient number of qualified teachers as per affiliation bye-laws are available before starting classes.
12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to students/parents every year without resorting to any hidden charges.
